Domiciliary Care

Domiciliary (Dom) Care is a supervised living arrangement in a home-like environment for adults who are unable to live alone because of age related impairments or physical, mental, or visual disabilities but not to the extent of requiring nursing home care. Dom Care is similar to a foster care program.

Domiciliary Care Consumer

Consumer eligibility for participation in the program includes:

- 18 Years or older and wanting to reside in Delaware County
- Cannot live independently because of physical or mental disability or other limitations

• Need assistance with cooking, cleaning, shopping, laundry, transportation, reminders for taking medicines & coordinating medical appointments

• Individuals must be able to maintain their own personal care &be able to make decisions that are safe & sensible in their daily living

Participation may be short-term/transitional or can become as permanent as needed. A structured, home atmosphere is the desired outcome for all participants in COSA's Domiciliary Care Program.

.....additional eligibility

After meeting the basic criteria for determining eligibility in DomCare, individuals are assessed by a COSA Assessment staff person. Final acceptance into the DomCare Program is determined by the County Assistance Office.

Consumers that receive Social Security or Social Security Disability, but do not earn the monthly stipend required for DomCare participation, must be approved for an additional supplement from Social Security that allows them to pay the Provider the monthly stipend and also to enjoy a monthly personal needs allowance. (determined annually by the Pennsylvania Department of Aging-Social Security provides supplement as needed)

Domiciliary Care Provider

Interested home providers must complete a certification process to assure that their homes meet fire, health & safety guidelines. Providers must also:

• Have criminal history clearances

• Have satisfactory financial, medical & personal references

- Attend on-going training sessions
- (State regulations require 4 training sessions annually)
- Work as a Team Member with Care Managers and Consumers
- Be 22 years of age, residing and living in Delaware County
- Must own & reside in home requesting certification ***landlord approval if home is rental
- Certification in CPR & First Aid
- Annual recertification to continue participation in DomCare Program
